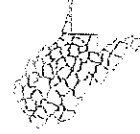
ADJOURNMENT:

I find that your levy rates to be imposed in excess of those prescribed by the West Virginia Constitution were legally authorized by a vote of the people.

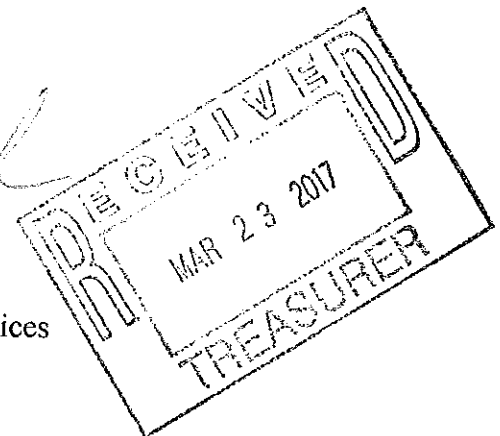


